This agreement is entered into between the FAIRVIEW UNION WATER SYSTEM, a non-profit corporation, hereinafter Called the "ASSOCIATION" and Bulk Water Purchasers of the Association, hereinafter called "Customer".

NOW THEREFORE, in consideration of the mutual covenants, promises and agreements herein contained, it is hereby understood and agreed:

The Association shall furnish, subject to the limitations set out in Rules and Regulations now in force and those hereinafter provided for, such quantity of water as the Customer may desire in connection with Association's fire hydrant at the designated location provided.

THE CUSTOMER DOES HEREBY DECLARE THAT HE/SHE IS THE OWNER OF ABOVE BUSINESS TO WHOM THE ASSOCIATION IS PROVIDING WATER.

The Association shall furnish a bulk water meter with a check valve and a shut off ball valve. The Customer is responsible for the fittings out of the shutoff valve to connect to their potable tanks or trucks.

The Customer also agrees to be fully responsible for the service line from the bulk water meter.

The Customer agrees to comply with and be bound by the Articles, Bylaws and Regulations of the Association now in force, or as hereafter duly and legally supplemented, amended or charged. The member also agrees to pay for water at such rates, time and place as shall be determined by the Association, and agrees to the imposition of such penalties for non-compliance as are now set out in the Association's Bylaws and Rules and Regulations, or which may be hereafter adopted and imposed by the Association.

The Association shall have final authority in the question of any service line connection to its water main line and shall determine the allocation of water to Customers in the event of a water shortage and may shut off water to a Customer who allows connection or extension to be made of the Member's service line for the purpose of supplying water to another user. In the event that total water supplies be insufficient to meet all the needs of the Members or in the event there is a shortage of water the Association may prorate the water available among domestic purposes before supplying any water for livestock and must satisfy all the needs of all members for both domestic use and livestock before supplying water for Bulk Water purposes.

The Customer agrees that no other present or future source of water will be connected to any water lines served by the Association's waterlines.

Water charges to the Customer shall commence of the date service is made available. Billing invoices will be sent via email or postal mail. The Customer agrees to pay a \$50.00 Monthly Meter Fee, and \$12.00 per thousand gallons consumed on a monthly basis. Customer agrees to call, send a picture, or bring the meter to the office at the first of each month so a reading can be taken from meter for billing purposes. Deposit will be refunded 30 Days after inspection of Association's meter and meter is returned in good shape. It is the customer's responsibility to maintain the meter in good shape and is responsible for keeping up with meter. The Association is only liable for the safe consumption of water when drawn from the delivery point of Association's connection. Once it is in the Customer's bulk water tank, truck or other delivery method used by Customer, the Association is no longer liable or assumes any responsibility for the safe consumption of the water purchased from Association. Initial:

The failure of a customer to pay water charges duly imposed shall result in the automatic imposition of the following penalties:

Initial______1. Non-payment by the 20th of the month shall be subject to a penalty of 10.00% of total bill.

Initial______ 2. Non-payment within 5 days from the due date will result in the water being shut off.

Initial______ 3. In the event it becomes necessary for the Association to shut off water service from the Customer there will be a \$100.00 penalty.

Initial______ 4. The \$100.00 meter deposit is in case of misuse of meter or if meter is not returned in good working order.
